ORDER

MADE UNDER THE COURTS ORDINANCE.

Cap. 4.

By virtue of the powers vested in me by subsection (1) of section 19 of the Courts Ordinance, I HEREBY ORDER as follows :-

Short title, 1. 1 ms Order, 1941. 1. This Order may be cited as the District Boundaries (Amend-

Amendment of the Schedule to Order appearing on pages 2-21 of Vol. III Revised Laws.

2. The Schedule to the Provinces and Districts (Boundaries) Order made under section 19 (1) of the Courts Ordinance appearing on pages 2-21 of Volume III of the Revised Laws is hereby amended by deleting that part thereof defining the boundaries of the Ahanta-Nzima District in the Western Province, and substituting therefor the following :---

(1) Ahanta-Nzima District, the boundary whereof-

- 1. Commencing at a point on the Gulf of Guinea marked by a boundary post No. 55, where the Anglo-French Boundary joins the coast line;
- 2. Thence follows the Anglo-French Boundary in a northerly direction to a point on the southern shore of Juen Lagoon marked by a boundary post No. 54;
- 3. Thence follows the Anglo-French Boundary in easterly and northerly directions to the point where that boundary leaves the left bank of the Tano river:
- 4. Thence follows the left bank of the Tano river to its junction with the Nini river;
- 5. Thence follows the thalweg of the Nini river to its source;
- 6. Thence runs in a straight line in a north-easterly direction to the junction of the Jirigum stream with the River Fura, about 7,000 feet south-east of Sechim:
- 7. Thence follows the thalweg of the Fura river in a south-easterly direction to Survey Beacon No. C.M.W.P.13/35/2 at the north-western corner of Anco Fura Concession:
- 8. Thence runs in an easterly direction along the northern boundary of Anco Fura Concession to Survey Beacon No. J.T.A.W.P.27/36/B.P.18;

- 9. Thence follows the southern boundary of Insimankao-Pedja Chwini Gold Mines Concession to Survey Beacon No. J.T.A.W.P.27/36/B.P.15 on the right bank of the Subri stream;
- 10. Thence follows the thalweg of the Subri stream in a southerly direction to its junction with the Ankobra river;
- 11. Thence follows the right bank of the Ankobra river to a point opposite the left bank of the Bonsa river at the confluence of these rivers;
- 12. Thence crosses the Ankobra river to the left bank of the Bonsa river at its junction with the Ankobra river;
- 13. Thence follows the left bank of the Bonsa river to its junction with the thalweg of the Nfutu river;
- 14. Thence follows the thalweg of the Nfutu river to its source, about 12,500 feet west of Dajwin;
- 15. Thence runs in a straight line in a southerly direction to a point about 6,500 feet west of Simpa, where the Kokruabaka stream joins the Insubente;
- 16. Thence runs in a straight line in a south-easterly direction until it cuts the northern boundary of the Akoko Aow Concession 8,500 feet from its north-east corner;
- 17. Thence runs eastwards and southwards along the northern and eastern boundaries of the Akoko Aow Concession;
- Thence runs westwards along the southern boundary to a point 4,200 feet west of the south-east corner of the Akoko Aow Concession;
- Thence runs in a straight line in a south-easterly direction to the junction of the rivers Taneiya and Nyan;
- 20. Thence follows the right bank of the Nyan river in a southerly direction to a point where the Nyan river is crossed by the main Sekondi-Axim Road (300W);
- 21. Thence follows the centre of that road in a northeasterly direction to Adiewoso so as to exclude the villages of Ajumako and Adiewoso from this district;
- 22. Thence runs in a straight line in a north-easterly direction to the north-west corner of the Ekukubaka Concession;
- 23. Thence follows the northern and eastern boundaries of the Ekukubaka Concession to the north-west corner of the Nada Kokler Concession; thence along

the northern boundary of the Nada Kokler Concession to the point where it is intersected by the western boundary of the Fan Cobbah Concession; thence northwards and eastwards along the western and northern boundaries to the north-east corner of the Fan Cobbah Concession;

- 24. Thence runs in a straight line in a north-easterly direction to a point where the main road from Aiyim to Aboadi crosses the Aiyemesu stream;
- 25. Thence runs in a straight line in a northerly direction to a point where the track from Trebuom joins the track from Aiyim to Impohaw about 6,000 feet south-east of Aiyim;
- 26. Thence runs in a straight line in a north-easterly direction to a point where the track from Nyamibechere joins the track from Domenasi to Impohaw about 1¹/₂ miles south of Domenasi;
- 27. Thence runs in a straight line in a south-easterly direction to the source of the Afri stream;
- 28. Thence follows the thalweg of the Afri stream in a southerly direction to its junction with the Nuenua stream about 15,000 feet in a north-easterly direction from Impohaw;
- 29. Thence runs in a straight line in a north-easterly direction to the south-western corner of the Arnankoldu Concession;
- 30. Thence follows the southern and eastern boundaries of the Arnankoldu and Darbimasie Concessions in easterly and northerly directions to the Nhwini river;
- 31. Thence follows the thalweg of the Nhwini river in an easterly direction to its junction with the Pra river;
- 32. Thence follows the thalweg of the Pra river in a southerly direction to the high water mark of the Gulf of Guinea;
- 33. Thence follows the high water mark of the Gulf of Guinea in a westerly direction to the Anglo-French Boundary, the point of commencement quoted in paragraph 1 above.

THE PROVINCES AND DISTRICTS (COLONY) (AMENDMENT) ORDER, 1947.

In exercise of the powers conferred upon him by section 19 of the Courts Ordinance, His Excellency the Governor has been pleased to make the following Order :---

1. This Order may be cited as the Provinces and Districts (Colony) (Amendment) Order, 1947, and shall be read as one with the Provinces and Districts (Colony) Order, 1946 (hereinafter referred to as the principal Order) and all amendments thereto, and shall be deemed to have come into operation on the 10th day of January, 1947.

2. Paragraph 3 of the principal Order is hereby amended-

- (a) by deleting the words " and Western Akim "; and
- (b) by deleting the comma between the words "Keta" and "Volta " and substituting therefor the word " and ".

3. The First Schedule to the principal Order (which defines and delimits the districts in the Eastern Province) is hereby amended-

- (a) by the deletion therefrom of paragraphs (4) and (7)relating respectively to the Birim and Western Akim Districts ; and
- " (4) The Birim District.

The boundary of the Birim District shall be as follows :----

- 1. Starting from the confluence of the River Volta and the River Obosum it follows the thalweg of the Obosum River to its junction with the Babadua Stream.
- 2. Thence it runs in a straight line in a south-westerly direction to the junction of the Afram and Onvim Rivers."
- 3. Thence it follows the thalweg of the Onyim River upstream to the junction of the Onyim and Supuni Rivers
- 4. Thence in a straight line in a south-easterly direction to the junction of the Fomang and Sutiri Rivers.
- 5. Thence it follows the thalweg of the Fomang River in a southerly direction to a point $\frac{1}{4}$ mile north of the road from Fomangso to Fomangkesi.
- 6. Thence it runs parallel on the northern side of and $\frac{1}{4}$ mile distant from the road from Fomangso through Mamfe and Ahireso to Kwahu Prasu until it reaches the left bank of the River Pra.

7. Thence it follows downstream the left bank of the River Pra to the point where the Kwahu-Kotoku boundary joins the River Pra.

- 8. Thence it follows downstream the left bank of the River Pra to its confluence with the River Fum.
- 9. Thence it follows the thalweg of the River Fum upstream to its confluence with the River Akenkawsu.
- 10. Thence it follows the thalweg of the River Akenkawsu upstream to a point approximately $\frac{1}{4}$ mile south of Akenkawso Railway Station on the Central Province Railway.
- 11. Thence it runs in a straight line in an easterly direction for approximately 103 miles until it reaches the main road from Kokoso to Achiasi and approximately 1 mile north of Asiakwa.
- 12. Thence it runs in a straight line in a south-easterly direction for approximately 14 miles to a point on the road from Odoben to Nyakrom and approximately 2 miles east of Odoben.
- 13. Thence it runs in a straight line in a north-easterly direction for approximately $8\frac{1}{2}$ miles to a point on the Akroso-Nsaba Road just south of the village of Eshient.
- 14. Thence it runs in a straight line in a north-northeasterly direction for approximately 7 miles to a point where the River Akora crosses the bush path from Asamankese to Akroso close to the village of Adiembra.
- 15. Thence it runs in a straight line in an easterly direction for approximately 61 miles to the village of Asuokaw where the River Avensu crosses the road from Asamankese to Nsawam.
- 16. Thence it follows the road from Asamankese to Nsawam in a south-easterly and easterly direction until it meets the town boundary of Adaiso to include in the district the road itself and all villages thereon.
- 17. Thence it follows the town boundary of Adaiso in a south-westerly, south-easterly, north-easterly and northwesterly direction until it meets the road from Adaiso to Nsawam.
- 18. Thence it follows the road from Adaiso to Nsawam until it meets the town boundary of Nsawam but so as to exclude from the district the road itself and all the villages thereon.
- 19. Thence it follows the town boundary of Nsawam in a southerly and easterly direction until it meets the River Densu.
- 20. Thence it follows the thalweg of the River Densu to its junction with the Stream Afene.
- 21. Thence it follows the thalweg of the Stream Afene to the boundary pillar about 2,000 yards upstream.

PROCLAMATION.

No. 1 of 1923.

By His Excellency Sir FREDERICK GORDON GUGGISBERG, Brigadier-General, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Companion of the Distinguished Service Order, Governor and Commander-in-Chief of the Gold Coast Colony, &c., &c., &c.

IN the exercise of all the powers and authorities in that behalf me enabling, I, Sir FREDERICK GORDON GUGGISBERG, Governor of the Gold Coast Colony, am hereby pleased to issue with respect to the British Sphere of Togoland this My Proclamation declaring, as it ishereby declared, as follows :----

1. This Proclamation may be cited as "The Administration (British Sphere of Togoland) Proclamation, 1923."

2. The British Sphere of Togoland is hereby divided into the following districts :---

(1) Northern Mamprussi (Togoland Section of);

(2) Kussassi (Togoland Section of);

(3) Southern Mamprussi (Togoland Section of);

(4) Eastern Gonja (Togoland Section of);

(5) Eastern Dagomba;

(6) Kratchi; and

(7) Ho.

3. The districts specified in clause 2 of this Proclamation under the numbers (1)—(6) shall be administered by the Chief Commissioner of the Northern Territories of the Gold Coast as Senior Political Officer, acting subject to the authority of the Governor; and the district specified in the said clause under the number (7) shall be administered by the Commissioner of the Eastern Province of the Gold Coast Colony as Senior Political Officer, acting subject to the authority of the Governor.

4. In the districts administered by the Chief Commissioner of the Northern Territories of the Gold Coast the Court of the Senior Political Officer may be presided over by the Circuit Judge of the said Protectorate, or by the Deputy Chief Commissioner thereof, who for the purposes of the administration of justice and of the holding of sessions of the said Court in the said districts shall have and may exercise all the power, jurisdiction, and authority, of the Senior Political Officer, but without derogation from the power, jurisdiction, or authority, of the Chief Commissioner of the said Protectorate.

5. The Togoland Proclamation issued by me on the fourth day of December, 1920 (Proclamation No. 35 of 1920), is hereby revoked.

Given under my hand and the Public Seal of the Gold Coast Colony, at Government House, Accra, in the said Colony, this 16th day of January, in the year of our Lord one thousand nine hundred and Twenty-three and of His Majesty's Reign the Thirteenth.
